MINISTRY SUPPORT NSW has a Christ centred vision to grow the resources available for initiatives in evangelism, church growth, spiritual renewal and church planting in NSW.

MINISTRY SUPPORT NSW has replaced the NSW Homeworkers Fund. The aim is to gather fresh thinking and encourage others to join the small group of faithful and generous supporters who sustained the Homeworkers Fund in recent years with the objectives of;

- *Promoting* the spread of Christianity through evangelism, teaching and pastoral care;
- Helping people come to saving faith in the Lord Jesus Christ:
- Contributing to spiritual growth and welfare of churches;
- Enabling people to engage in a full time or part time role in Christian ministry in NSW; and
- Supporting the ministries of para-church organisations.

MINISTRY SUPPORT NSW will also help Christians take up opportunities in ministry training and theological studies to grow the skill base and resources available to churches and para church organisations in NSW.

Financial assistance may be provided in one of three ways:

- A monthly contribution for a period of three years toward the support of a ministry worker engaged in church planting, church revitalisation or a new evangelistic ministry initiative; or
- 2. Assistance for theological study or ministry training by contributing to tuition fees or cost of books and reference material for people committed to entering a ministry role in a Christian Community Church or assembly or para-church organisation in NSW; or
- 3. One off seed funding for initiatives to help a church with limited financial resources upgrade a vital item of equipment or train its members, eg data projector, presentation software, ministry training for a music team, etc.

MINISTRY SUPPORT NSW can distribute designated gifts to particular ministry workers in churches and assemblies in NSW on behalf of churches, individuals or organisations.

MINISTRY SUPPORT NSW will coordinate a Christmas Gift Appeal each year.

TRANSPARENCY - a financial report on the operation of **MINISTRY SUPPORT NSW** will be presented at each meeting of the NSW Coordinating Conference.
